Questions and Answers about CCO's Monthly Giving Plan

Won't I lose control of my banking?

No, you continue to have control just as with cheques you have written. You can adjust the amount of your donation or discontinue donations altogether, if desired, by contacting CCO in writing.

What if I change banks or accounts?

Should you change accounts, advise CCO of the change in writing so your donations can continue uninterrupted. Simply mail us the appropriate information for the new account or credit card and the change will be made.

What about my records?

Your donations are recorded automatically on your monthly bank or credit card statement. You can continue to enter your donations in your personal transaction record book to ensure consistency with your bank or credit card statements.

When would donations be debited from my account?

Your donation would be drawn from your bank account or credit card on or around the 1st or the 16th of each month, depending on your personal preference. It usually takes one month for your monthly withdrawals to begin.
